

SECURITY LIGHT AGREEMENT

The undersigned ("Member") hereby agrees to lease _____ security light(s) from Wise Electric Cooperative, Inc. ("Cooperative") upon the following terms and conditions:

TERM: This service agreement shall continue in force for an initial term of _____ years from the date the cooperative installs the security light(s).

RATE: \$_____ per month per light for lights rated at _____ watts. This rate is applicable to single or multiple-controlled dusk to dawn outdoor lighting installed and maintained by the Cooperative. Service will be furnished under this rate subject to the established rules and regulations of the Cooperative covering this type of service. In the event of a rate change prior to the expiration of this contract for electric service, the minimum charge will never be less than that set out in the applicable rate schedule.

BILLING ADJUSTMENTS: This rate is subject to all applicable billing adjustments. Power cost recovery factor (PCRF) adjustments will be based on the kilowatt-hour estimate as more fully described in Cooperative's tariffs per month per _____ watt light.

CONDITIONS OF SERVICE: For each security light installation, the Cooperative will install one luminaire complete with lamp, lamp operating equipment, mounting pole (if necessary), and one span of 120 volt secondary line not in excess of 125 feet. If the Cooperative is required to construct facilities in excess of those stated above, the Cooperative shall charge the customer directly for the net cost of providing such additional facilities in accordance with the Cooperative's current Contribution In Aid Of Construction.

The Cooperative will, at its own cost and expense, replace all related inoperative equipment. All expenses covering replacement of security light equipment due to vandalism or other breakage may be borne by the Customer.

The electric service contracted for herein is to be provided and taken in accordance with the provisions of this Agreement and the Cooperative's staff. SAID TARIFF IS A PART OF THIS AGREEMENT TO THE SAME EXTENT AS IF FULLY SET OUT HEREIN AND IS ON FILE AND AVAILABLE AT THE COOPERATIVE'S MAIN OFFICE LOCATED IN DECATUR, TEXAS. Any tariff provision (including rates) may be changed by order or consent of any regulatory authority having jurisdiction thereof whether or not at the request of the Cooperative.

PAYMENT: Member agrees to pay for service in accordance with the Cooperative's tariff. Periodically, the Cooperative will remit to Member a statement for services rendered. Payment shall be made to Cooperative at its office in Decatur, Texas or Bowie, Texas.
